It is possible that the date may change under new administration but as of now that is the date. Attached with the Klarion is a sheet from the DMV which has what the differences are between the standard license, enhanced license and real ID. The Read Id is indicated by a star on your license where the flag indicates the enhanced ID. Although these work for domestic travel a passport is required for international travel. Both Linda & Janice mentioned that they have worked hard with their staff on customer service as the DMV has had a rather negative reputation in the past. At the time Linda was elected County Clerk there was a turnover of staff so that she was able to instill a good work ethic and positive attitude in the DMV workforce. They mentioned that it is important when going to the DMV to bring proper ID with you. You need your social Security Card plus 2 proofs of NY State Residency. Those include a Passport or birth certificate & 4 additional documents - utility bill, credit or debit card, Paystub, Marriage Certificate etc..
